



2018 CERTIFIED MEDICATION AIDE 8-HOUR UPDATE

A Certified Medication Aide shall renew certification every twelve (12) months. Recertification requires documentation of completion of at least eight (8) hours of continuing education every twelve (12) months, excluding the first year, after certification as a medication aide. In addition, certification as a Long Term Care Aide, Home Health Aide or Developmentally Disabled Direct Care Aide must be current.

Care Providers Oklahoma is sponsoring continuing education programs for 2018, approved by the Oklahoma State Department of Health, which will provide the required 8 hours necessary to renew the certification of CMA's.

Medications and the Elderly will be the main topic of discussion in 2018. Pharmacist and Nurses will provide education to the CMA on the role they play and the medications they are responsible for giving to residents in the senior living facilities. Additional presentations on requirements of participation and current issues will also be discussed.
